



Quick Guide: My Funding Conditions

This information product enables you to explore data, from 2017, for certain Youth Guarantee (YG) and Student Achievement Component (SAC) levels 1 and 2 funding conditions. You can see data on your delivery volume and non-compliance. This information product enables you to monitor your non-compliance at the year level and National Student Number (NSN).

Examples of what you can discover

- Compliance with funding conditions over time by source of funding.
- Delivery volume reported through the Single Data Return (SDR) compared to delivery volume committed to in the mix of provision.
- Ability to drill down to NSN level to identify the source of the non-compliance.
- Funding conditions by year for reference.

Things to note

- Data in this information product will update when an SDR submission is received.
- Tabulated data will present with the highest non-compliance first.
- For some sheets, non-compliance is measured using:
 - data available to you Tertiary Education Organisation (the TEO), shown graphically with a blue bar in the graph, and blue text in the table, and
 - data not available to you (the TEO), shown graphically with a red dot in the graph and the last columns in the table.
- Data available to you is SDR information submitted by you, and information on the learner's New Zealand Qualifications Authority (NZQA) 'Record of Achievement' (RoA). If you have questions about accessing data on learner RoAs, contact NZQA's Qualifications Data and Data Analysis team on 0800 697 296.
- Data not available to you is SDR information submitted by other TEOs.
- For the monitoring of these funding conditions, your non-compliance is measured using data reported by you in your SDR and data available from the learners RoA.
- For other sheets, blue text in the table shows you the key non-compliance measure.
- Funding conditions can change over time. Refer to the funding conditions by fund and year sheet, or to our website for the actual funding conditions.
