Tertiary Education Report: Letters for Ministerial appointments to eight tertiary education institution councils

Purpose

1. This paper provides you with the letters needed to complete appointments to eight tertiary education institution councils. It also provides you with draft letters to notify the council Chairs about your decisions and a letter of thanks to the outgoing Ministerial appointee.

Background

- 2. The Cabinet meeting of 25 March 2019 noted your intention to make the following appointments, all of which are effective from 1 May 2019 to 30 April 2020:

 - Reappoint Mr Andrew ENGLAND as a council member of Tai Poutini Polytechnic.
 - Reappoint Ms Ngaroma TAHANA as a council member of Toi Ohomai Institute of Technology.
 - Appoint Mr Lyal FRENCH-WRIGHT as a council member of UCOL and reappoint him as a council member and as Deputy Chair of WITT.
 - Reappoint Mr Robin BROCKIE as a council member and as Chair of WITT.
- 3. Letters to the Ministerial appointees are attached for your signature (Appendix A refers). Two documents are attached to the letters of appointment:
 - a. a declaration and consent form for the purposes of obtaining consent to the appointment, confirmation of eligibility and a declaration of any conflicts of interest; and
 - b. a summary of Ministerial expectations of all TEI council members.
