Purpose

Your responsibility

4. The Crown Entities Act 2004 requires you to present TEC's SOI and SPE to the House of Representatives before or on the date the TEC Annual Report for the year ended 30 June 2019 is presented (SOI [s149 CEA]) (SPE [s249L CEA]). Our Annual Report is likely to be published and provided to you to table in the House of Representative in November 2019.

6. We will liaise with your office to determine when to provide the Bills Office with the required 30 copies of both our SOI and SPE and a PDF file.
