Purpose

1. This briefing seeks your signature, as responsible Minister on the settlement agreement between AUT and AT on the A2B project.

Key points for consideration

- 2. Auckland Transport (AT) together with NZ Transport Agency Waka Kotahi is responsible for the designation, funding, construction and operation of the Airport to Botany Bus Rapid Transit Project (A2B). The A2B project involves a dedicated Bus Rapid Transit Corridor (BRT), centrerunning in each direction for the majority of the corridor along Te Irirangi Drive, Great South Road, Ronwood Avenue, Manukau Station Road, Lambie Drive and Puhinui Road to provide a high capacity, frequent and reliable BRT service.
- 3. The University and AT have undertaken negotiations to develop a clear process and terms between the parties on the development of the A2B project, and its impact on the development and operations of AUT's south campus.
- 4. You, as responsible Minister, hold a designation over the campus under s177(1)(b) of the Resource Management Act 1991 (RMA) and this will take precedence over any subsequent designation obtained by AT for the A2B project. Following advice from the TEC and following a review of the in-principle draft of the settlement, you agreed to be co-signatory on the final agreement.
- 5. The legal representative has notified TEC that there have been minor amendments to the agreement since February 2025, but the substantive obligations remain the same. The changes include:
 - a. Correcting and clarifying cross referencing
 - b. Introducing a definition for "Directly Adjacent Works" to clarify obligations that apply when AT is undertaking works that are close to, but not inside the AUT property boundary.
- 6. AT and AUT have signed the updated agreement and are sending you the final version for your approval (your office will be receiving this directly).
- 7. The TEC considers that agreeing to the settlement agreement put forward will resolve the issue to the satisfaction of all parties and allow the A2B project to progress.
