

# Event backgrounder: Local Government New Zealand Rural and Provincial Meeting

# Purpose

- You are scheduled to meet with the Chief Executives and Mayors from fifty rural and provincial councils on 7 March between 12.30-1.00pm, at the Harbourside Function Venue 4 Taranaki Street, Wellington.
- Attendees are looking to hear your vision on the Reform of Vocational Education proposals, and how these will benefit the broader skills pipeline in the regions. This event backgrounder provides you with information on key attendees and matters that may be raised.
- 3. We recommend that this paper be proactively released along with other material when decisions about the consultation on the Reform of Vocational Education are announced.

## Information about the workshop and your attendance

- 4. This is the first of three annual meetings which brings together the CE's and Mayors from provincial and regional councils throughout New Zealand (there are 78 councils throughout NZ in total). The gathering is arranged and chaired by Local Government NZ (LGNZ). Their discussions in relation to the proposed Reform of Vocational Education will likely focus on three areas: regional education/training, employment, and the impact on regions (where appropriate) of the proposed creation of a New Zealand Institute of Skills & Technology.
- 5. The CE's and Mayors are gathering at 9am and you are scheduled to speak between 12.30 and 1pm. Your speaking slot allows for 10 to 15 minutes to share your vision for vocational education, followed by an opportunity for questions from the attendees.
- 6. Aside from the topics mentioned above, participants are also likely to ask questions about the consultation and engagement process, and how they can become involved in this.

## Matters attendees may raise with you and proposed responses

7. How do the proposed reforms for both the new ITP and new skill bodies (ISBs) promote regional development

One of the key themes of both the ITP and Skills reform proposal is to provide more involvement and input for regional stakeholders regarding skills requirements, which in turn is aimed at providing better outcomes for regional bodies, learners, and industry. At the moment

we have a system where campuses compete with each other for learners, and then compete with industry training organisations to place learners into training. In the future we expect the different parts of the system to work together in a more joined up fashion; to understand and identify regional skill needs, ensure the right qualifications are available, and then delivery training where it's needed at the right time.

8. Each region is unique with different challenges, how will your proposal recognise these differences and work within them?

To ensure a strong regional presence, each region would have a Regional Leadership Group to identify local skills needs and link with regional economic development strategies and action plans. The committees would have strong local government and industry participation, and representation of and a strategic partnership with local iwi and Pacific communities.

9. We have a polytechnic in our area and it's a major contributor to our regional economy. What guarantees can you provide that the proposed reforms won't result in mass disruption, job losses, and less responsiveness to skill needs?

We admit the proposed changes are significant, far reaching, and disruptive. We are faced, however, with a situation where we don't have the skills we need across a number of regions, and most providers are struggling at a time when they should be prosperous. There is still a lot of work to be done before a decision is made about the overall structure and operation of the new institution, which includes getting everyone's feedback during the consultation process. What we can assume however, is that the learners currently in training now will continue to need support for quite some time, where ever they are. What we are trying to do is allow for more skills, not less – and if the proposed reforms are put in place we believe it will result in a better training system in the regions. Ultimately a more efficient and sustainable institution going forward will be better for everyone.

10. There is a need for more highly skilled people in the regions, how will your proposals improve the current situation?

An integrated system could better meet the needs of learners and employers and link providerbased and work-based training. The proposed changes will position the vocational education system to deliver for the future. It will also help to ensure that industry has more of a say in the types of skills needed for industry success, and to ensure that education providers are flexible in providing both work-based and provider-based educational training.

11. How will you ensure the voice of industry is heard through your proposals?

In the proposed new system design, the national skills leadership role of ISBs would be complemented by employer and/or industry leadership at a regional level. Employers and industry would have more choice about how they engage with vocational education providers to meet the skill needs of their current and future workforce. They would also have a choice of education providers to work with, rather than having to arrange on-job training via their ITO. Better integration of workplace and provider based vocational education programmes would enable employees to gain the skills that employers and industry need.

12. How can we get more involved in the consultation and engagement process?

The Korero Matauranga website (the Education Conversation) lists a number of events we are holding around the country, including community engagement days. We are also currently arranging some industry association forums, and will put information on our website as soon as these are arrangements. We would also strongly encourage you to provide a written submission in response to the proposals.

# Attendees of note

- 13. There are a number of invitees that have connections to the tertiary education sector, a number of which we have included information about below. A full list of attendees is included as Appendix One.
- **Dave Cull** is the President of Local Government New Zealand, and also the Mayor of Dunedin. He has opposed the proposals publically.
- **Steve Ruru**, Chief Executive (CE) of of Southland District Council, is a Ministerial appointment to the council of Te Wananga o Aotearoa.
- **Tim Shadbolt**, Invercargill's Mayor, is a strong advocate for Southern Institute of Technology, and has publically opposed the Reform of Vocational Education proposals (please see Appendix Two).
- The former Mayor of Whanganui, **Annette Main**, is a council member of Universal College of Learning.
- The Chair of Eastern Institute of Technology (EIT) is a council member of Hastings District Council, and you have Mayor **Sandra Hazlehurst** and CE **Nigel Buckle** attending. EIT Ministerial appointee **Jacoby Poulain** is also a Councillor for the Flaxmere Ward.
- Janie Annear is the Deputy Chair of Ara Institute of Canterbury and was three-term mayor of Timaru District council –current Mayor Damon Odey and CE Bede Curran are also attending.
- While the Chair of Waikato Institute of Technology (**Barry Harris**) is not attending, he used to be the CE of Greater Wellington Regional Council and Hamilton City Council, so is bound to have Waikato District Council connections.

## Appendix Two: Media commentary

15. Tim Shadbolt has made several comments about the proposals in the media, including the following:

"It will be devastating quite frankly; we are being punished for being successful," he said.

"It will have an impact on international students, and we have travelled all around the world recruiting, also the loss of our assets and our cash reserves."

He said he would fight against the proposal, which is open for public consultation until March 27, and said it wasn't the first battle SIT had faced.

"They tried to take \$8 million out of our budget, as they said we didn't need the money whereas other institutions were running at a loss and that was about ten years ago."

16. Dave Cull has publically announced that he is behind Otago Polytechnic and will ensure his communities concerns are represented throughout the consultation process.

"The proposed merger risks undoing a lot of good work and would see Otago Polytechnic potentially being subservient to an organisational structure that may not understand or care about our local needs," Mr Cull said.

"We need to ensure that our polytechnic can maintain its individual character and specialisations, as this is one of the main drawcards for local and international students alike, and what sets it apart from so many others."

The timing was poor as major projects such as the new hospital and central city and tertiary precinct upgrades were about to start, *Mr* Cull said.

"We need Otago to remain autonomous, and flexible and responsive to local needs.

"I've been in touch with Phil Ker to let him know the city is behind them and will be doing all we can to make our community's views heard loud and clear."
