Where does the data for Tahatū qualifications come from?

Tahatū qualification data is sourced from the data that tertiary providers submit in DXP Ngā Kete for provider-based and work-based education. This includes enrolments, fields of study, duration, credit value and fees.

How are qualifications in Tahatū organised?

Qualifications are organised into clusters of similar qualifications to ensure that learners can navigate according to their areas of interest. The clusters are a combination of:

- New Zealand Qualifications and Credentials Framework (NZQCF*) level or level range
- a modified version of a detailed New Zealand Standard Classification of Education (NZSCED**) field of study.

** NZSCED is a system used to categorise educational qualifications in New Zealand.

What makes a qualification appear in a cluster?

Qualifications will appear in a cluster with a particular field of study if enough graduates have completed enough courses (university papers) in that field of study.

Qualifications can appear in more than one cluster depending on:

- the courses that learners completed within a particular qualification
- the NZSCED codes the tertiary provider has submitted for those courses and qualifications.

Why don't some qualifications appear on Tahatū?

An institution's qualification won't appear on Tahatū if:

- it is a new qualification that was submitted after the last Tahatū data update (data updates happen annually around the middle of each year)
- it is not funded by TEC
- it is worth less than 40 credits
- no learners were enrolled in the current or previous year
- it has no New Zealand-based learners enrolled.

The following types of qualifications also won't appear on Tahatū:

- Secondary to Tertiary Alignment Resource (STAR) qualifications, for example:
 - o Introduction to working with children
 - Introduction to hairdressing.
- Trades Academy, off-job training, non-formal qualifications, micro-credentials, certificates of proficiency, training schemes.
- Conjoint degrees, for example:
 - o Bachelor of Health Science/Bachelor of Laws.
